Section 367-A

PPC-Kidnapping or abducting in order to subject person to unnatural lust

Punishment

Shall be punished with death or rigorous imprisonment for a term which may extend to twenty-live years, and shall also be liable to fine.

Section 370

Punishment

Buying or disposing of any person as a slave Shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine.

Section 374

Unlawful compulsory labour:

Punishment

Shall be punished with imprisonment of either description for a term which may extend to five years or with fine, or with both.




