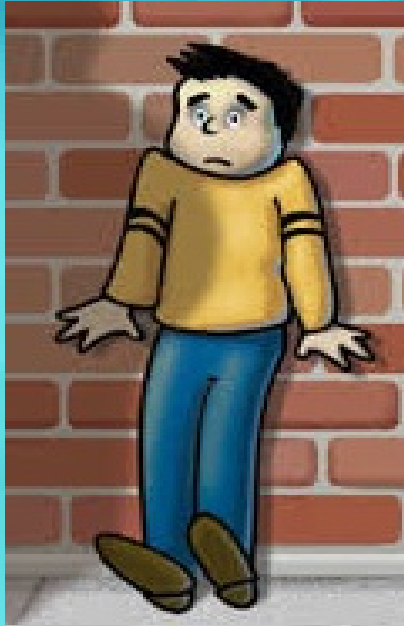

Section 367-A

PPC-Kidnapping or abducting in order to subject person to unnatural lust

Punishment

Shall be punished with **death or rigorous imprisonment for a term which may extend to **twenty-five years**, and shall also be liable to fine.**

Section 370

Buying or disposing of any person as a slave

Punishment

Shall be punished with imprisonment of either description for a term which may **extend to seven years, and shall also be liable to fine.**

Section 374

Unlawful compulsory labour:

Punishment

Shall be punished with imprisonment of either description for a term which may **extend to five years or with fine, or with both.**

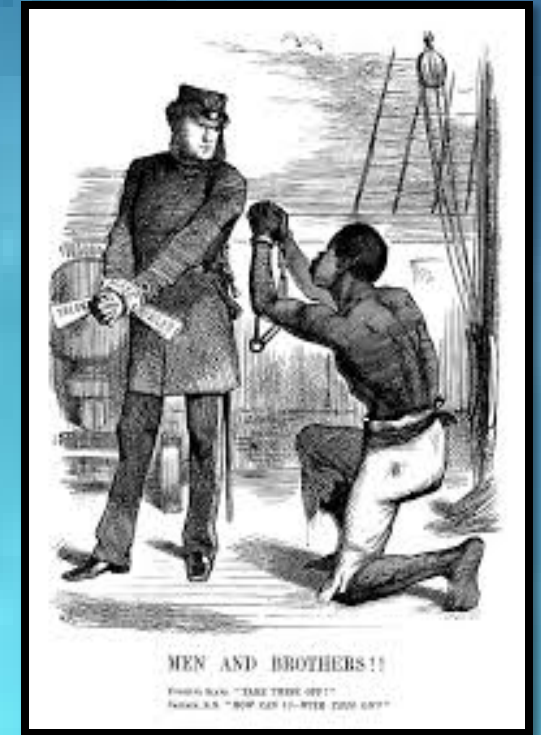
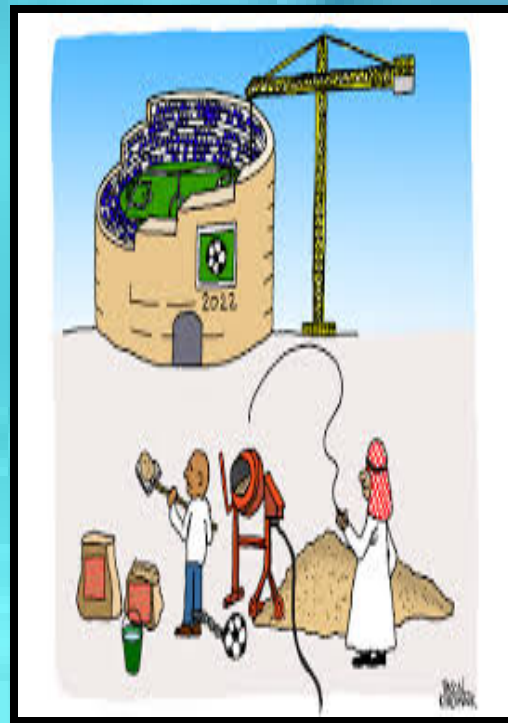

D- Assault, Kidnapping , illegal confinement (Minors and women)

Section 503, PPC- Criminal Intimidation:

- 1 Threatening a person with any injury
- 2 Threat must be with intent

Section 509, PPC- Insulting modesty or causing sexual harassment

Punishment

Shall be punished with **imprisonment which may extend to three years** or with fine up to **five hundred thousand rupees** or with both

INSULTING MODESTY OR CAUSING SEXUAL HARASSMENT

Section 509, PPC Insulting modesty or causing sexual

Punishment

Shall be punished with imprisonment which may extend to **three years or with fine up to five hundred thousand rupees or with both**

Section 366-A, PPC

Punishment

Procurator of minor girl shall be punishable with imprisonment which may extend to **ten years and shall also be liable to fine.**

Section 366-B, PPC

Importation of girl from foreign country

Punishment

Shall be punishable with imprisonment which may **extend to ten years** and shall also be liable to **fine**.

Section 367

Kidnapping or abducting in order to subject person to grievous hurt, slavery, etc

Punishment

Shall be punishable with imprisonment which may **extend to ten years** and shall also be liable to **fine**

Section 367-A, PPC

Kidnapping or abducting in order to subject person to unnatural lust

Punishment

Shall be punished with death or rigorous imprisonment for a term which may extend to **twenty-five years, and shall also be liable to fine.**

Section 368, PPC

Wrongfully concealing or keeping in confinement, kidnapped or abducted person:

Punishment

Such person shall be punished in the same manner as if he had kidnapped or abducted Such person with the same **intention or knowledge, or for the same purposes**

CRIMES AGAINST PROPERTY

SEC 397 Punishment for theft

Shall be punished with imprisonment of either description for a term which may extend to three years, or with fine, or with both

B- ROBBERY



**Sec, 393 PPC
Punishment**

Not be less than three years nor more than ten years, and shall also be liable to fine; robbery be committed on the highway the imprisonment may be extended to fourteen years

**Section 394, PPC
Punishment**

Imprisonment for life, or with rigorous imprisonment for a term [which shall not be less than four years nor more than ten years, and shall also be liable to fine.

Dacoity (Section 391- PPC)

Shall be punished with imprisonment for life, or with rigorous imprisonment for a term which shall not be less than four years nor more than ten years and shall also be liable to fine.

SECTION 396 PPC DACOITY WITH MURDER

PPC
Punishment

Shall be punished with death, or imprisonment for life, or rigorous imprisonment for a term which shall not be less than four years nor more than ten years, and shall also be liable to fine.

SECTION 397, PPC - ROBBERY OR DACOITY, WITH ATTEMPT TO CAUSE DEATH OR GRIEVOUS HURT

Section 394, PPC Punishment

If, at the time of committing robbery or dacoity, the offender uses any deadly weapon, or causes grievous hurt to any person or attempts to cause death or grievous hurt to any person the imprisonment with which such offender shall **be punished shall not be less than seven years.**

C. MISAPPROPRIATION AND BREACH OF TRUST

Section 403, PPC Dishonest misappropriation of property:

Punishment Shall be punished with imprisonment of either description for a term which may extend to two years, or with fine, or with both.

Section 405, PPC Criminal breach of trust:

SEC 406, PPC Punishment for criminal breach of trust Shall be punished with imprisonment of either description for a term which may extend to 7 years, or with fine, or with both.

which may extend to one year, or with fine, or with both

Section 420, PPC-

Punishment

Cheating and dishonestly inducing delivery of property

which may extend to seven years, and shall also be liable to fine.

Fraud (Section 25- PPC)

Section 421, PPC

Dishonest or fraudulent removal or conceal property to prevent among creditors

Punishment

which may extend to two years, or with fine or with both.

Section 422, PPC

Dishonestly or fraudulently preventing debt being available for creditors distribution

Punishment

which may extend to two years, or with fine, or with both

Section 423, PPC

Dishonest or fraudulent execution of deed of transfer containing false statement of consideration:

Punishment

which may extend to two years, or with fine, or with both

Section 424, PPC

Dishonest or fraudulent removal or concealment of property

Punishment

Which may extend to two years, or with fine, or with both.

Mischief, Arson and Destruction of Property

Mischief (Section 425- PPC)

Which may extend to three months, or with fine, or with both.

★ **Section 435, PPC
PUNISHMENT**

Mischief by fire or explosive substance with intent to cause damage to amount of one hundred rupees or (in case of agricultural produce) ten rupees

★ **Section 426, PPC**

Mischief by fire or explosive substance with intent to destroy house, etc

PUNISHMENT

Imprisonment which shall not be less than three years nor more than ten years, and shall also be liable to fine

OFFENCES AGAINST THE STATE

Terrorism and Waging War Against the State

PUNISHMENT

Shall be punished with death, or imprisonment for life and shall also be liable to fine.

Section 121-A, PPC

Conspiracy to commit offences punishable by Section 121

Section 122, PPC

Collecting arms, etc., with intention of waging war against Pakistan

PUNISHMENT

Imprisonment for life or imprisonment of either description for a term not exceeding ten years, and shall also be liable to fine

Section 123, PPC

Concealing with intent to facilitate design to wage war

PUNISHMENT

which may extend to ten years, and shall also be liable to fine

B- Seditious or Treason

Assaulting President, Governor, etc., with intention to compel or restrain the exercise of any lawful power

C- Illegal Possession of Arms and Ammunition

Arms Ordinance, 1965

بہتیار آرڈیننس 1965

- Section 4 Unlicensed sale and repair prohibited
- Section 8 Prohibition of going armed without licence
- Section 9 Unlicensed possession of arms etc.

- Section 13 Penalty for breach of Sections 4, 5, 8 to 11

Shall be punished with imprisonment for a term which may extend to seven years or with fine, or with both

Provided that the punishment for an offence committed in respect of any rifle of .303 bore or over, musket of .410 bore or over, pistol or revolver of .441 bore or over or ammunition which, can be fired from such musket, pistol or revolver, shall be imprisonment for a term which is not less than three years, shall be imprisonment for a term Which is not less than three years.

Section 13-A Penalty for, breach of Section 4 in respect of cannon or automatic weapon, etc.

Imprisonment for a term which may extend to fourteen years and shall not be less than seven years, fine and forfeiture of property

Section 13-B Penalty for breach of Section 8 or Section 9 in respect of cannon or automatic weapon, etc

Imprisonment for a term which may extend to ten years and shall not be less than three years and fine.

Sindh Arms Act, 2013



Section 23: Offences and Penalties

23. (1) Sindh Arms Act

23 (a)

Acquires, possesses, carries or control any firearm or ammunition in infringement of section 3, **shall be punishable with imprisonment for a term which may extend to fourteen years and with fine**

PUNISHMENT
23 A (B, C D,
E, F, G)

Shall be punishable with imprisonment for a term which may extend to ten years and with fine.

23 (2)

Whoever being a person to whom provisions of section 8 Punishment for certain offences. 10 applies, acquires, possesses or carries any firearm or ammunition in contravention of that section shall be punishable with imprisonment for a term which may extend to **seven years and with fine**

Punishment for Rioting

Shall be punished with imprisonment of either description for a term which may extend to two years, or with fine, or with both.

Section 148 PPC

Rioting, armed with deadly weapon

shall be punished with imprisonment of either description for a term which may extend to three years, or with fine, or with both.
